## ***JEAN SHEPHERD ROOM DEDICATED AT CASA OFFICE***

With dozens of friends, colleagues, family members and CASA volunteers and staff on hand, Judge Shepherd performed the official ribbon cutting to dedicate the new *Jean Shepherd Room* at Douglas County CASA on December 15. Pictured above, Judge Shepherd's grandchildren assist with the ribbon cutting ceremony at the CASA office. The room features a sign above the doorway with letters painted by CASA children, volunteers and staff (sign is pictured at right). The *Jean Shepherd Room* is used for children's activities, volunteer meetings and trainings, and other small gatherings. A tribute to Judge Shepherd and her years of service in child welfare and family court law, the *Jean Shepherd Room* provides a meaningful legacy that will be enjoyed by the vulnerable children served by CASA and their CASA volunteers for many years to come. The first female Judge appointed in Douglas County in 1984, Judge Shepherd retired in January. She founded Douglas County CASA in 1991 and the Citizen Review Board in 1986. Her legacy inspires us all.

## LOCAL YOUTH MAKE A DIFFERENCE: GIRL SCOUT GOLD AWARD PROJECT PROVIDES PLAYHOUSE FOR FOSTER HOME



Community service is an important tradition in the Girl Scouts organization, and Douglas County CASA was honored to be the recipient of an extraordinary service project completed by Free State High School juniors Melinda Landgraf and Hannah Whipple. For their Girl Scout Gold Award project, Hannah and Melinda designed, constructed, and donated a charming playhouse that was placed in an area foster home. This project required more than 65 hours of volunteer work, which included months of planning and recruiting donated supplies. Due to an assorted mix of donations and resources, Hannah and Melinda had to draw heavily upon their creativity to design and build this special playhouse. Their design was inspired by various birdhouses decorated by CASA children.

The teens have been in Girl Scouts for a combined total of 20 years and both have achieved the Girl Scout Silver Award. For their Gold Award project, they decided to attempt a unique project that required a variety of skills and would make a positive difference for children in foster care. The end result was a charming playhouse that was a dream come true for vulnerable children in the community. Despite cold temperatures, the playhouse received a heart-warming welcome in its new home and the walls are already echoing with the laughter of excited children.

## Volunteer Profile: CASA Making a Difference in San Diego



### **The Cause: Voices for Children**

**Jenna Price, 45**

**Hometown:** San Diego

**Family:** Husband, Joseph; daughter, Audrey, 10

Jenna Price and Jacob\*, 14, love spending time together, but she isn't Jacob's mom or teacher. She's his Court Appointed Special Advocate (CASA)—and the reason that Jacob, a former foster child, now has a permanent home.

CASA volunteers are assigned by judges to look after abused and neglected kids in the foster care system. These mentors are often the only constant in a childhood filled with changing homes and faces. Since CASA's 1977 inception, its advocates have served more than 2 million kids.

Jenna, a former attorney and current stay-at-home mom, was at a work event 12 years ago when she heard about CASA's San Diego chapter, Voices for Children, and she signed up

immediately. "There's potential in all of these children," says Jenna, who has since overseen seven foster kids. "They just need someone to pay attention to what's going on in their lives."

In 2005, Jenna met Jacob, then 9. Since entering foster care three years earlier, he had moved six times. Jacob was scared and angry, and he had trouble trusting people. Because of his multiple placements and emotional instability, he had been deemed "unadoptable," meaning he would be in foster care until age 18. But Jenna had hope for Jacob. Rather than concentrating on his past troubles, she focused on what the two of them could do in the present to shape a positive future. Jenna built his trust by spending time with him—they'd go on hikes and visit the zoo together.

She worked tirelessly to find Jacob the right classes and teachers to help him succeed at school, and she went to court to fight for his right to a foster home that could meet his needs. When Jacob was 11, the court saw his progress and reversed the unadoptable decision; soon after, he met the couple who became his adoptive parents.

Jenna's experience with CASA has taught her that by being there for a child you can create enormous and exciting changes in his life. "Kids like Jacob have been through so much," she says. "But there's still this wonderful spirit inside."

## MARCH 7 IN-SERVICE WORKSHOP: TRAUMA-INFORMED CARE

With information particularly relevant for CASA volunteers, our March in-service focuses on “Trauma-Informed Care” and will be presented by Toni Detherage from the service agency “Seasons.” This in-service will take place at the CASA Office on Monday March 7, 2011 (NO KU Basketball that evening) from 5:30-7:00p.m.

Toni also works with “Success by 6,” but has branched out to provide comprehensive trauma-focused services in a different setting and that is core of her work with “Seasons”.

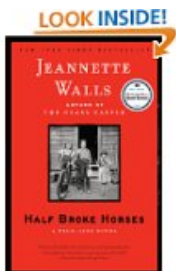
Nearly all of the children with whom CASA Volunteers worked have suffered significant trauma. Volunteers witness this as they come to know and work with these children. And they might also witness the effects of past trauma in the parents of these children. So, understanding the profoundly unsettling effects of trauma is important for our work with these children and their families.

Trauma is defined as a sudden or unexpected event that people understand as dangerous. It involves threats or actual physical harm and can overwhelm a person’s ability to cope. Feelings of helplessness, intense fear and a lack of control also characterize trauma.

Complex trauma includes sexual abuse, physical abuse, severe neglect and witnessing domestic violence. It is important to understand that complex trauma changes the way our brains develop and function; it can interfere with neurobiological development with accompanying negative impacts for emotional health and social functioning.

Toni and “Seasons” are committed to educating service providers like CASA Volunteers about the long-term neurological, developmental and emotional effects of living with trauma. Her in-service will serve as a valuable step in this educational process.
