## Court Appointed Special Advocates for Children - OCTOBER 2010

Dr. Phil and his wife, Robin, are official spokespersons for CASA, the National Court Appointed Special Advocate Association. It is CASA's mission to support and promote court-appointed volunteer advocacy for abused and neglected children so they can thrive in safe, permanent homes.



### CASA Cause Featured on *Dr. Phil* Show

The *Dr. Phil Show* on Friday, October 1 focused on the experiences of the 25,000 older youth who are in foster care each year. In the recent episode, Dr. Phil called on caring adults to stand up as advocates for these youth, serve as their advisors, to help them develop specific transition plans, identify positive adult connections and achieve future success.

The show featured young people who are preparing to age out of foster care or have aged out of care, including youth who spent the summer on Capitol Hill as members of the Congressional Coalition on Adoption Institute's internship program. Also appearing on the "No Child Forgotten" episode of *Dr. Phil* were US Senators Mary Landrieu and Chuck Grassley. Grassley is the co-founder of the Senate Caucus on Foster Youth, and both senators are longtime proponents of foster youth and of the CASA cause.

Dr. Phil and Robin McGraw are national spokespeople for the CASA network. Whether you are a fan of *Dr. Phil* or not, his support of the CASA cause on the *Dr. Phil* show has resulted in the recruitment of thousands of new volunteers nationwide to advocate for the safety and best interests of abused and neglected children. ## Jessica Cummings: Finding the Time to Help Children

CASA of the 5th Judicial Circuit, Jackson County, West Virginia

One day I saw an ad in our community newspaper announcing that a new CASA program was starting, and it called to me. I cut that ad out and set it on my desk. In the shuffle of papers, it kept rising to the top. About a week later, I called the program.

I was in the first class to be trained, that was about three years ago. I was the youngest member of that class, and to this day I am the youngest volunteer in the program.

***I find that a lot of younger people—people in their 20s and 30s—feel that their lives are so busy that they cannot find time to become involved in CASA. That is simply not true.***

We find time to do the things we love. We find time to watch television, we find time to talk on the phone, we find time to get onto Facebook. We can find some time in our day to devote to these children, who need us so desperately.

I was appointed my very first case five days after being sworn in. I went into the office and my coordinator told me that I was being appointed to a sibling group of five children ranging in age from 3 to 15 years old. The case involved physical abuse, emotional abuse, substance abuse. It was very complex, and I was pretty busy at the time.

***But these children deserved to have somebody to stand up for them, so I took the case.***

The oldest child was a teenage girl. I had been told by department folks that she was a problem: "She needs special education classes, she needs medication, she needs therapy, she has anger management issues...."

When I met the child, I immediately saw that she had been pegged completely wrong. The problem was with the home, not with the child. I was appalled to think that the critical, condemning information I had received about her was the only information the judge was receiving.

The minute she and her younger siblings were removed from that home into a good home—a safe home, a permanent home—she changed. Since the very semester that she was moved, she has had over a 3.8 grade point average. She's involved in school activities, in church. She's not bitter about what happened to her. She is a shining light, an example.

***In the end, it isn't what I did for her, it is what she did for me. She showed me resilience, and that you can do anything.***



### October is Domestic Violence Awareness Month

The American Psychological Association estimates that 40-70% of men who frequently abuse their partners also abuse their children.

#### Responding to Disclosure of Domestic Violence\*

What to say to the child who has been exposed to domestic violence:

- I believe you.
- I'm glad you told me. Sometimes people are afraid to talk about it.
- No one deserves to be hurt.
- The abuse is not your fault.
- Let's talk about what you can do when something happens. Is there a safe place you can go (bedroom, neighbor's house, outside)?

## **OCTOBER 14 IN-SERVICE WORKSHOP: Educational Advocacy for CASA Kids**

In order to best support the children with whom they work, CASA volunteers frequently solicit valuable feedback from teachers and other school personnel. This can include educational assessments, classroom behavioral observations and social functioning reports. Providing this information to the Court enhances a greater understanding of CASA kids, as permanency is pursued for these children.

Also, many CASA kids benefit from the additional school support provided by Individualized Educational Plans (IEPs) and 504 Plans. Assisting with these plans, however, can be perplexing for Volunteers. Knowing if they might be useful or appropriate can be challenging and their implementation process can seem overwhelming for volunteers.

CASA volunteer Sue Richardson and School Psychologist Renee’ Dexter will answer all your questions about this type of school support at the October CASA In-Service. Sue has a Masters Degree in Special Education and worked as a Middle School Counselor in the Shawnee Heights School District for 25 years. Dr. Dexter is currently a school psychologist for the Shawnee Heights School District. Together, they probably know just about all there is to know about this process.
