**WHITEMAN ENLISTED SPOUSES CLUB CONSTITUTION AND BYLAWS
ARTICLE X: DISSOLUTION AND FINAL DISTRIBUTION OF FUNDS**

The membership is liable under the laws of the State of Missouri for organizational debts in the event the organization's assets are insufficient to discharge liabilities. The members of the WESC are advised that the WESC is not a government instrumentality but a non-profit organization that the United States Government will not be liable for the payment of in the personal liability of all active and associate members, even though the WESC may be dissolved. Assets abandoned by the WESC on or after it dis-establishment may be acquired by Whiteman Air Force Base under the terms of existing policy on the matters and consistent with the laws applicable to Whiteman Air Force Base. Any funds remaining in the treasury after satisfaction of all outstanding debts, liabilities, and obligations may be redistributed to the Enlisted Spouses Club or its equivalent at any other base within the Air Force Global Strike Command, or may be used to support an on or off base charity or charities that reflect favorably on the WESC and the Air Force. A majority of the voting members present at the last regular meeting must approve the disbursement of funds.
