This 24,000+ Sq. foot building is clean, well lighted and secure with a huge parking lot and large doors you can drive into for easy unloading.

Our Bird Fair will be held June 14 & 15, 2008, vendor set up beginning at 1:00 P.M. on Friday, June 13. 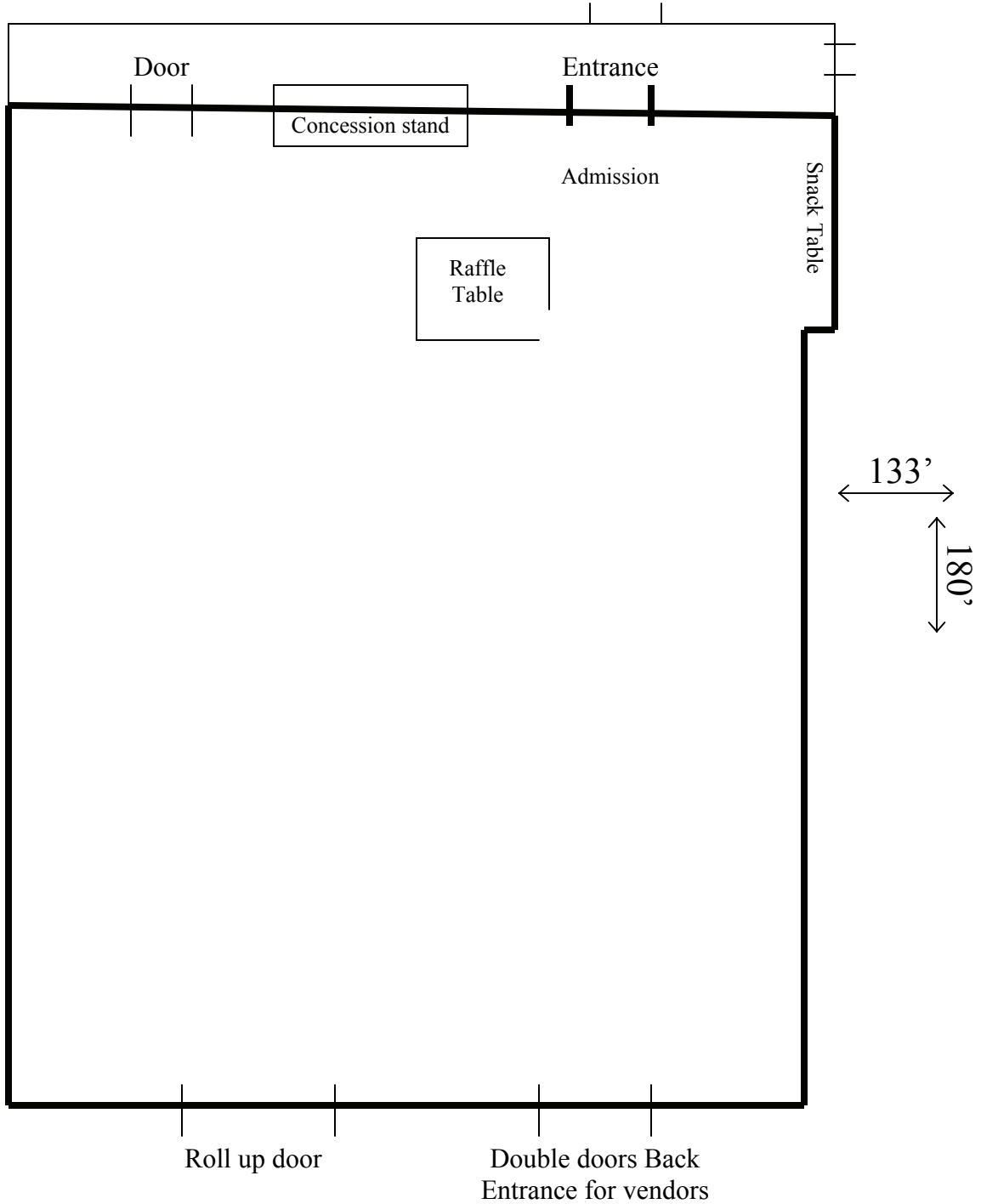

Please select your preferred location and write in how many tables and/or spaces you require. Also, if you need electricity at your table, please bring your own extension cords. All outlets are located along the walls and a few on the floor through out the building. We will do our best to place you at your choice of location, however, the first requests that come in will be honored. This is a first class building, so please bring your own newspapers and clean-up supplies so we can keep it neat. CMBC will furnish several vacuum cleaners for your use. Loading doors are located at the back of the building. CMBC members will be available to help or answer questions.

BIRD FAIR VENDOR RULES

In striving to improve the success of our annual fair, we ask all vendors adhere to the following guidelines. These will benefit all participants.

- Send in your reservation form & check as soon possible to ensure your table(s) will be reserved. Tables will be rented on a first come, first served basis, vendors will not be reminded by telephone or letter.
- Each vendor will be responsible for manning his/her own table(s) and maintaining the area around their table(s). Tables must remain in the original position & articles for sale must not block the aisles.
- The club reserves the right to have any questionable birds or any items not pertaining to the cage bird fancy to be removed from the premises. **No pigeons, chickens, peafowl, etc. will be allowed. No mammals will be allowed for sale or raffle.**
- The club will not be responsible for any disagreements arising from items bought or sold at this event. Responsibility for the resolution of such disagreements will be between buyer & seller. Prices charged will be at the discretion of the seller. It is suggested that live bird sales be accompanied by a receipt which includes the sellers name and phone number.
- The club will not be responsible for lost or stolen items. We suggest your table be manned at all times. Club members are available to relieve those attending without partners.
 - Please supervise all children in your care.
- It is recommended that potential customers & other participants disinfectant their hands before & after handling any bird. We request exhibitors NOT bring birds that have been in their possession less than 30 days. We request that exhibitors refrain from allowing un-feathered chicks to be handled at the fair, un-feathered chicks should be exhibited in a clear container so they may be seen and not touched. Un-weaned chicks should not be sold to individuals inexperienced in hand feeding. **Please have hand sanitizer available on your table for the public to use before handling your birds.**
- Cages housing live birds must be clean. Clean food & water must be provided for weaned birds at all times. All birds must be kept in humane surroundings.
- Birds displaying obvious signs of illness will not be allowed. do not bring birds exhibiting signs of illness. Sales of sick birds give bird fairs a bad reputation.
 - All vendors are responsible for collection & payment of Mississippi sales tax.

Unless prior approval has been obtained from CMBC.
