PARADE THEME: "There's No Place Like Home North Olmsted"

Any club, street, commercial organization, and all parade lovers, both young and old, may participate by submitting an entry form, by invitation or by permission of the Parade Committee.

Awards will be made in each of these classifications: "NON-COMMERCIAL", "COMMERCIAL", and "JUNIOR". Cash prizes of \$50.00, \$25.00, and \$10.00 will be awarded to the first, second, and third place winners respectively in the "NON-COMMERCIAL" category. Trophies will be presented to first, second, and third place winners in the "COMMERCIAL" category. A cash award of \$15.00 and trophy will be given to the first place winner only in the "JUNIOR" category. (Junior floats must be built and manned by youths of 18 years of age and younger.) Parade Committee reserves the right to award honorable mention to those junior floats that the Judges select. A Grand Prize of \$100.00 cash will be awarded to the Best Float in the Parade. All entries will be judged enroute on the theme, detail, effort, originality, and ingenuity. Conformity to theme will be the only basis of eligibility for an award. Leading citizens from other communities will be judging. Float entries must be no more than 16 feet high and 10 feet wide.

- SPECIAL REGULATIONS:**
1. **NOTHING IS TO BE THROWN FROM ANY PARADE ENTRY.**
 2. **ITEMS APPROVED BY THE PARADE COMMITTEE ARE THE ONLY ITEMS PERMITTED TO BE HANDED TO PARADE SPECTATORS ON THE SIDELINES.**
 3. **COMMERCIAL ENTRIES THAT DON'T HAVE FLOATS THERE WILL BE A FIFTY DOLLAR CHARGE FOR ENTRY. OR THE ENTRY CAN BUY ADD SPACE IN THE HOMECOMING BROCHURE AND ENTER THE PARADE FREE.**
 4. **ALL PARTICIPANTS WILL PROVIDE IDENTIFYING SIGNS AND ATTACH THEM TO BOTH SIDES OF THE VEHICLES. SIGN SHOULD NOT EXCEED THE STANDARD POSTER SIZE OF 22 INCHES BY 28 INCHES.**
 5. **VIOLATORS WILL BE REMOVED FROM THE PARADE AND BARRED FROM FUTURE PARTICIPATION.**
 6. **IN THE EVENT OF AN EMERGENCY, ALL PARTICIPANTS WILL MOVE TOWARD THE RIGHT CURB AND COME TO A HALT-REMAINING THERE UNTIL SIGNALLED TO PROCEED.**
 7. **NO UNLICENSED MOTOR VEHICLES ARE PERMITTED. ALL DRIVERS ARE REQUIRED TO SUPPLY PROOF OF INSURANCE FOR THE MOTOR VEHICLE THAT THEY ARE OPERATING.**

DEADLINE: ALL ENTRIES MUST BE IN BY AUGUST 18, 2005. LATER ENTRIES MAY NOT BE ELIGIBLE FOR JUDGING AND WILL BE PLACED AT THE REAR OF THE PARADE.
