## **GENERAL INFORMATION**

As part of its mission of character development, Minsi Trails Council, BSA and Ballard Angels, a charitable organization recognizes that all BSA registered youth, with no regard to race or religion, should have a quality summer camp experience.

The Ballard Angels Camp Scholarship Fund was established to assist in making the council's vision a reality by providing financial assistance to BSA registered youth of the Hazleton or Weatherly School Districts to attend camp. **The Ballard Angels Camp Scholarship is limited to Minsi Trails Council Resident Camps or Minsi Trails Council Day Camps.**

## **ELIGIBILITY**

To be eligible for financial assistance, a youth must:

1. Be registered with a Pack, Troop, or Crew within Anthracite District of Minsi Trails Council.
2. Provide descriptive reason for financial assistance.
3. Provide proof of school grades of "C" or better (please copy latest report card).
4. 80% attendance rate within the unit (verified by unit leader).
5. Show proof of legal residency in the United States (please copy SS card and black out the first five numbers).
6. Be recommended for a camp scholarship by his/her unit leader.
7. Be approved by the Camp Scholarship Committee.

Families with multiple youth must submit a separate application request for each youth requesting a scholarship. Please complete the application and submit using the form on the reverse side of this page. The application must be signed by the youth's parent or legal guardian and unit leader.
