

**ENTRIES OPEN January 16, 2012 \*\*\* ENTRIES CLOSE February 16, 2012**

- 1) Entry shall be open to members of the Tri-County USBC WBA. Dual members of other associations who bowl in certified leagues in this association may enter. Every entrant must be a member of USBC and Wisconsin Women's State Association.
- 2) The tournament shall consist of a five-woman team event; a doubles event; a singles event and an optional all events. Three (3) consecutive games shall be bowled in each event and total pins shall decide the winner. The total of nine (9) games bowled shall determine the all events winner.
- 3) Entrants shall **use their highest Tri-County USBC WBA average at the end of the 2010-11 season for at least 21 games**. If an entrant has no previous average, she shall be permitted to bowl using her highest current average of at least 12 games as of tournament start date. Any entrant not meeting these requirements shall bowl scratch (200). Rule 319e does not apply. Rule 319a(2) does not apply.
- 4) Tournament dates as per entry blank.
- 5) Tournament shall be handicap. Handicap shall be 80% of the difference between 200 and the entering average.
- 6) **Entry Fee is \$12.00 per bowler - per event (3 events) + \$2 optional all events (Total \$38)**

- 7) **MAKE CHECKS PAYABLE TO TRI-COUNTY USBC WBA . . . NO ENTRY FEE WILL BE RETURNED.**
- 8) An entrant **may participate in the team event without limitation; but not more than three players can place more than once in the prize list**. Make up teams are allowed. Substitutes and woman members from certified mixed leagues are eligible to bowl also.
- 9) An entrant **may participate in the doubles and singles events without limitation; but in no case shall the same two women team be permitted to place more than once in the prize list**. An entrant can **only place once in the singles prize list**.
- 10) **When a bowler competes more than once, her highest score in each event shall count towards her all events score.**
- 11) Substitutes are allowed when replacement is necessary. The tournament official shall be notified at least ONE HOUR before the scheduled bowling time.
- 12) The lineup will be the same as shown on the entry form.
- 13) Entries will be scheduled according to requests if possible and in the order received.
- 14) The captains shall check in the entire team 1/2 hour prior to the scheduled time. All bowlers in the doubles/singles events shall check in 1/2 hour before the scheduled bowling time.
- 15) Any player or team arriving after the game has started will be allowed to bowl and the scores will be counted beginning in the frame being bowled. **(No score will be given for frames missed.)**
- 16) Any protest affecting the eligibility of playing rules must be confirmed in writing to the President of the Association before the tournament prize payments will be made. Errors in scoring must be reported within 48 hours.
- 17) Prize money paid into each event will be returned to the winners in that event only. Prizes will be paid for handicap scores with at least one prize for each five entries. The local association will provide Champion Plaques and the USBC Awards will be presented to the winners.
- 18) **NO FOOD OR BEVERAGE WILL BE ALLOWED IN THE PLAYING AREA, EXCEPT FOR MEDICAL REASONS.**
- 19) Official scorers will be furnished by the association.
- 20) The Board of Directors of the Tri-County USBC WBA shall decide any question not covered by these tournament rules. The Board shall have the power to hear and act on all protests arising from or under the construction of the rules of the tournament.
